The concurring vote of a majority of the ZBA is necessary to reverse an order, requirement, decision or determination of an administrative official of body or to decide in favor of the applicant on any matter upon which they are require to pass or to affect any variation in the Zoning Ordinance. Any aggrieved person may take an appeal.

Standards for Variance Review

Sec. 78-789 of the Village of Middlevile Zoning Ordinance describes the standards for reviewing a dimensional variance. A dimensional variance is a variance pertaining to any practical difficulty in complying with the zoning ordinance based on the dimensional characteristics of a lot, parcel or property, exceptional topographic or other conditions of the land, buildings or structures. The Zoning Board of Appeals must make findings as to each of the 5 standards for a variance. A variance shall not be authorized unless the board makes findings, based upon competent material and substantial evidence on the whole record. In order to be approved, you must receive no less than three concurring votes.
