RESOLUTION NO. 18-20

RESOLUTION TO SCHEDULE PUBLIC HEARING ON THE VACATION AND DISCONTINUATION OF THE REMAINING PORTION OF LINCOLN STREET IN ASSESSOR'S PLAT NO. 3 OF MIDDLEVILLE, A RECORDED PLAT

WHEREAS, the Village Council of the Village of Middleville considers it advisable to vacate, discontinue and abolish the remaining open portion of Lincoln Street located west of Grand Rapids Street within the Village, which is an improved platted street, within Assessor's Plat No. 3 of Middleville, as recorded in Liber 1 of Plats, Page 25, being part of Section 27, Town 4 North, Range 10 West, Barry County, Michigan, more particularly described as:

Portion of Lincoln Street to be Vacated:

All that part of Lincoln Street lying between Blocks 11 and 12 of Assessor's Plat No. 3 of Middleville, as recorded in Liber 3 of Plats, Page 11, Section 23, Towns 4 North, Range 10 West, Barry County, Michigan, more particularly described as:

Beginning at the Northeast corner of Lot 1, Block 11 of Assessor's Plat No. 3 of Middleville; thence along the North line of Lots 1 and 2, Block 11, North 89° West 264 feet to the Northwest corner of said Lot 2; thence North 1° East 66 feet to the Southwest corner of Lot 7, Block 12 of Assessor's Plat No. 3 of Middleville; thence along the South line of Lots 7 and 8, Block 12, South 89° East 264 feet to the

Southeast corner of said Lot 8; thence South 1° West 66 feet to the Point of Beginning.

; and

WHEREAS, pursuant to the General Law Village Act, when the Village Council considers it advisable to vacate, discontinue or abolish a public street, it shall by resolution declare its intent to do so and appoint a time not less than four (4) weeks after the date of the resolution when it shall meet and hear objections to the resolution; and

WHEREAS, notice of the meeting to be held to consider the vacation of streets within the Village, with a copy of the resolution attached, shall be given in accordance with the Open Meetings Act.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

1. The Village Council considers it advisable to vacate, discontinue and abolish the portion of Lincoln Street described as follows and as shown on the attached Exhibit A; subject to the reservation of a public utility easement and access to such easement by the Village for Village purposes:

Portion of Lincoln Street to be Vacated:

All that part of Lincoln Street lying between Blocks 11 and 12 of Assessor's Plat No. 3 of Middleville, as recorded in Liber 3 of Plats, Page 11, Section 23, Towns 4 North, Range 10 West, Barry County, Michigan, more particularly described as:

Beginning at the Northeast corner of Lot 1, Block 11 of Assessor's Plat No. 3 of Middleville; thence along the North line of Lots 1 and 2, Block 11, North 89° West 264 feet to the Northwest corner of said Lot 2; thence North 1° East 66 feet to the Southwest corner of Lot 7, Block 12 of Assessor's Plat No. 3 of Middleville; thence along the South line of Lots 7 and 8, Block 12, South 89° East 264 feet to the Southeast corner of said Lot 8; thence South 1° West 66 feet to the Point of Beginning.

2. The Village Council intends to consider the adoption of a resolution to abandon the foregoing lands at a meeting of the Village Council to be held on October 9, 2018, at 7:00 p.m., or

shortly thereafter. The Village Council shall at that time meet and hear objections to the resolution to vacate.

- 3. Notice of the October 9, 2018 meeting, with a copy of this resolution attached, shall be posted in the manner prescribed by the Michigan Open Meetings Act.
